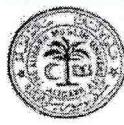

**1. Guest Teacher - Senior Legal Practitioners (03-Posts)**

**Essential Qualifications: –**

1. At least a higher second class recognized LL.B./B.A.LL.B. degree of Indian University or an equivalent foreign qualification.
2. At least 15 years of practice/experience in the District Court / High Court as a Lawyer.

2. The non-refundable Processing Fee for each Application Form is Rs. 500/- and is to be paid only in the Online Mode at the Careers Portal. However, **PwD candidates are exempted from payment of prescribed Processing Fee**, in case they upload an authentic Disability Certificate on the prescribed Proforma with the Application Form.
3. Applicants must follow all the instructions as given in the Advertisement and the User Manual available on the Careers Portal.
