Applications on prescribed form are invited for appointment of Assistant Professor (Shia Theology) Faculty of Theology AMU, Aligarh for the academic session 2021-22.

THE APPOINTMENT WILL BE MADE AS ASSISTANT PROFESSOR (CONTRACTUAL fixed salary and to be filled as per UGC norms) purely on temporary basis and liable to termination at any time without any notice assignment of reason.

ELIGIBILITY A OR B:

'A'

- (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or Fazil of any well reputed Shia Madrasa with adequate knowledge of English or an equivalent degree from an accredited foreign university.
- (ii) A Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time; as the case may be.

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be eligible for recruitment and appointment of Assistant Professor or equivalent positions in the University subject to the fulfillment of the following conditions:

- (a) *The Ph.D. degree of the candidate has been awarded in a regular mode;*
- (b) *The Ph.D. thesis has been evaluated by at least two external examiners;*
- (c) *An open Ph.D. viva voce of the candidate has been conducted;*
- (d) *The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;*
- (e) *The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency. The fulfillment of above conditions is to be certified by the Registrar/Controller of Examinations of the University.*

OR 'B'

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS)
- (ii) The Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai). NOTE: A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Class (Non-Creamy Layer)/Differently-Abled ((a) Blindness and low vision; (b) Deaf and Hard Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing Good Academic Record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedures.

- Applications received late or without necessary supporting documents/certificate/mark sheets and experience certificate not attested by the Head of the Department/Institute/Gazette Officer/self-attestation shall be rejected summarily.
